Discussion approve disapprove Dickes building & culvert permits

Dickes said that she turned in three different permits. One permit was to demo a small building behind her house. She said they would like to remove that building an install a building to store a camper and park her vehicles. She said that all of her permits went before the Planning & Zoning Commission. The demolition permit was approved, but the culvert and building permits where denied. They wanted proof stating that all three lots where actually one

lot. The building that they were planning on building would reside on two of the three lots that they own. Dickes said that she is willing to follow all the laws.

Wilken explained that there is already and existing culvert in their alley. They are trying to tie into the culvert for the driveway. Cadwell said that the accountant told her that it will take a lot of time and cost a lot of money to amortize all those items Her recommendation was to move a limit up to \$2500.00 or \$5000.00. Starr made a motion for the fixed asset policy be moved from \$300.00 to \$2500.00. Wilken seconded the motion.

Discussion approve disapprove purchase of electrical supplies

This is an item that was approved by three board members prior but they wanted it added to the agenda so they know what was actually ordered. They saved 4 dollars a stick by getting the whole bundle.

Discussion approve disapprove tree trimming & electrical work in concession area

Gerlach would like to see the tree in the park trimmed. He said that he tried to get in the concession stand and wasn't able to. Piehl thinks that soccer has the key to the lock. Gerlach said that he would like to see two more receptacles put in at the concession stand. Stewart thought that there was only 20-amp service so they would not be able to do that, but he will discuss this with the electrician.

Discussion approve disapprove purchase of trash cans

Gerlach provided the board with bids for trash cans. They discussed mounting the trash cans if they spend the money on the trash cans.

Discussion approve disapprove electrical upgrades, concession stand, canopy, & gazebo

Gerlach provide a list of repairs that needed to be made at the park. He said that someone working down at the park reported getting shocked by an electric receptacle. Gerlach said that noticed that the park lacks gfi receptables. He pointed out that the board is rotten. He said that he opened the electric panel while he was down there. He said that all the breakers are full and it is only a 100-amp service. He said that the transformer is for a 200- or 300-amp service. He said that it could be upgraded if needed.

Gerlach made a motion to approve the electrical upgrades, concession stand, canopy, and gazebo with most relevant items to be completed first. Mack seconded the motion.
