

ORDINANCE NO. 511

AN ORDINANCE OF THE VILLAGE OF GREENWOOD, CASS COUNTY, NEBRASKA, TO ADOPT A MASTER FEE SCHEDULE FOR ALL FEES FOR ANY ZONING OR SUBDIVISION RELATED ACTION OR PERMIT REQUEST; TO PROVIDE FOR FEES FOR FAILURE TO OBTAIN A PERMIT FOR BUILDING; ZONING OR SUBDIVISIONS; TO PROVIDE FOR ITS IMPLEMENTATION; TO PROVIDE FOR THE SEVERABILITY OF ANY SECTION, CLAUSE, PROVISION OR PORTION FOUND UNCONSTITUTIONAL OR INVALID; TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE THAT THIS ORDINANCE SHALL BE PUBLISHED EITHER IN PAMPHLET FORM OR BY POSTING; AND TO PROVIDE THAT THIS ORDINANCE SHALL NOT BE MADE A PART OF THE MUNICIPAL CODE OF THE VILLAGE OF GREENWOOD, NEBRASKA.

WHEREAS, the Village Board of Trustees has adopted a Zoning Ordinance and a Subdivision Ordinance and also, provides for Building Permits for construction within the corporate limits and the extraterritorial jurisdiction of the Village, and

WHEREAS, Zoning Ordinance Section 4.27 provides that the payment of fees for zoning and subdivisions shall be adopted by the Village Board under a Master Fee Schedule and adopted by separate Ordinance, and

WHEREAS, as a result of construction and use of properties occurring without property owners and occupiers failing to obtain a permit prior to construction and use, fees to encourage owners and occupiers to obtain proper permits is deemed to be in the best interests of the Village,

NOW, THEREFORE, BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF GREENWOOD, NEBRASKA, as follows:

Section 1. That the findings here and above should be, and they are hereby made a part of this Ordinance, as fully as if set out at length herein.

Section 2. That the following MASTER FEE SCHEDULE for Building, Zoning and Subdivisions shall be adopted:

* ACTUAL COSTS – A deposit may be required in addition to the fee if the estimate of actual costs exceed \$1000.00. The actual fee will be billed to the applicant and must be paid within 30 days of billing and prior to any permits being issued. The deposit shall be applied to actual fees and if there is excess, returned to applicant	

Section 3. That the Chairman of the Board of Trustees of the Village of Greenwood, Nebraska, and its Clerk, are hereby authorized and directed to implement this Ordinance.

Section 4. That should any section, paragraph, sentence or word of this Ordinance hereby adopted be declared for any reason to be invalid, it is the intent of the Chairman and Board of Trustees of the Village of Greenwood that it would have passed all other portions of this Ordinance independent of the elimination herefrom of any such portion as may be declared invalid.

Section 5. That all ordinances and parts of ordinances passed and approved prior to the passage, approval, and publication of this Ordinance, in conflict herewith, are hereby repealed.



That this Ordinance shall be published either by posting in three (3) public places in the Village of Greenwood, Nebraska, or in pamphlet form and shall be effective on the fifteenth (15th) day from and after its passage and approval, provided it has been published, as aforementioned, within the first fifteen (15) days after its passage and approval.

Section 7. That it is the intention of the Chairman and Board of Trustees of the Village of Greenwood, Nebraska, and it is hereby ordained that the provisions of this Ordinance shall not become or be made a part of the Municipal Code of the Village of Greenwood, Nebraska.



RESOLUTION 21-3

WHEREAS, the governing Body of the Village of Greenwood, Cass County, Nebraska reviewed the fees for services, licenses, and permits as established in Resolution 21-1, and

WHEREAS, the Village Board of Trustees of the Village of Greenwood, Nebraska, as the Village of Greenwood's Governing Body, has determined that Zoning, Building and Subdivision Regulations shall be set out by Ordinance,

NOW, THEREFORE, BE IT RESOLVED, by the Chairman and the Village Board of Trustees of the Village of Greenwood, Nebraska to adopt the following fees, to wit:


